IMPORTANT INFO - **EVERYONE MUST WEAR A MASK.** SHIELDS ARE OK FOR COACHES.

\$3 entry fee for spectators – CASH ONLY PLEASE. (2 spectators per player)

COACHES: You must arrive at least 30 minutes before the tournament. Please enter the gym **before your players and parents.** Bring in a roster with the names of your players and the names of their **2 spectators ONLY.** Parents must be on list to enter the gym. Tell your kids to **bring their own water bottles.** **3 teams per court - they either play or ref.** You and all your parents will **sign a covid waiver and wear masks.** **Bring your own pen** for scorekeeping. We'll provide the score sheet.

SPECTATORS: We will **not be selling food** at our tournaments so people can keep their masks on. You **must be on the list provided by your coach to enter.** **A sibling counts as one of the spectators.** **Social distancing seats are marked** - please respect them or you will be removed from the gym. Spectators will **sign in** as they enter, after we have received the roster from their coach. Spectators will go **to their seats and remain there** unless their team changes courts when we go to bracket play. Bring your own water bottle, as fountains are closed. All eating must be done in your car. Non-compliance to the COVID rules will require you to leave the gym.

First place teams in each pool move to Court 1. Second place teams to Court 2. Third place teams to Court 3. Bracket play includes a round robin format, however, due to time restraints - Bracket play allows for 2 sets per match and best record wins. No third games will be played. (It is not single elimination - you will play 2 matches in bracket play)

Please do not park on the roadway up toward the RV park - they will tow you. There is parking on top of the hill to the north of the gym.

One day only tournament formats:

- 3 Team Pool Play: Three 21 point sets. Beginning at 4-4, no cap.
- 4 Team Pool Play where all teams advance to playoffs: Two 21 point sets. Beginning at 4-4, no cap.
- 4 Team Pool Play where not all teams advance to playoffs: Three 21 point sets. Beginning at 4-4, no cap.
- 5 Team Pool Play: Two 21 point sets. Beginning at 4-4, no cap.
- 6 Team Pool Play: Two 21 point sets. Beginning at 4-4, no cap.
- 7 Team Pool Play: Two 21 point sets. Beginning at 4-4, no cap.

Playoffs will be two out of three sets, first 2 - 21 point (no cap). Third set, if necessary will be a 15 point with NO cap. During Playoffs the losing team is required to officiate the following match.
