**Comments:**

The gym entrance is on the northwest corner of the property. Enter one of the farthest west driveways. Address is 8506 E Central. There is plenty of camping space, as well as bleacher seating. Wifi is not available.

Please make sure you and anyone helping you coach is wearing their credentials at all times. If you do not have yours yet, please make sure to show me your membership card when checking in, along with an ID.

Parents/athletes are permitted to bring in small coolers that can hold water bottles, snacks, etc. Large coolers are not allowed, nor are any appliances like crockpots. There will be a concession stand with lunch options; cash and Venmo will be accepted.

There will not be an entrance fee.

13s division (Auxiliary Gym): Teams in the 13s division WILL switch sides each set, because of the setup of the gym. There will not be a lunch break. All teams will advance to bracket play. The top 2 in each pool will advance to an upper bracket; the bottom 2 to a lower bracket. Medals will be awarded to the first and second place teams in the upper bracket, and to the first place team in the lower bracket.

15s division (Main Gym): Teams in the 15s division will NOT switch sides, unless determined one team has a clear disadvantage. There will not be a lunch break. All teams will advance to bracket play. The top 2 in each pool will advance to an upper bracket; the bottom 2 to a lower bracket. Medals will be awarded to the first and second place teams in the upper bracket, and to the first place team in the lower bracket.

- 7 Team Pool Play: Two sets to 25. Beginning at 4-4, no cap.
- 9 Teams on 3 Courts: Two sets to 25. Beginning at 4-4, no cap.
