13s & 14s Division: 2 pools of 5 will play a single round robin consisting of 2 sets to 25 points starting at 4-4. Top 3 teams from each pool will advance to single elimination playoffs and awards will be given to the 1st place team and 2nd place team.

Perry Lecompton High/Middle School House Rules:

1. Outside food and drinks are allowed. Please keep all food and drink in the camp area and not in the gym. We will have a concessions provided by the PLHS Volleyball team. All profits go toward their program. Reasonably priced items!!
2. Please clean up your camp area when your team is finished competing. **If the tournament director asks you to clean up your area, please respect their directions.**
3. All kids need to stay with their parents. Absolutely NO ball or horse play is allowed in the camp area. **If the tournament director has to redirect your child, please respect their directions.**
4. Address for PLHS is 404 Lecompton Road Perry, KS 66073. The gym is on the south west side of the campus.

Coaches: Please stop at the tournament desk near the concessions. Please have your credentials and ID ready for check in. Make sure your rosters are correct and complete. All players listed on the tournament entry form MUST be registered with HOA.

Coaches meeting will take place at 7:45am. If you have any questions, please contact tournament director Shelbie Morgison at 785.806.0916

First team to referee, please arrive at 7:30 AM and make sure that the net is at the correct height, and all supplies at the scorer's table.

After 3rd match, all matches should start 2 minutes after previous match.

Warm-ups: When teams are playing their first match of the day: 2 minutes ball handling, each team on their side of the net. After that, there will be 4 minutes court time for the Serving team, followed by 4 minutes court time for the receiving team.

Coaches Credentials: Each coach that wants to be on the bench must have their credentials. If you cannot show them, you will have to show your membership card, proof of IMPACT certification and a picture ID. If you cannot show proof of impact certification and/or membership you can NOT coach! The only adults that can be on a team bench are the ones that wear the green credentials. The only adults that are to help at the scorer's table do lines or help with shagging balls either have to wear the red Parent member credential or the green coach's credential. All coaches are to wear the credentials around their neck, clearly visible, always.

Playoffs: Playoffs will be two out of three games, first 2 - 25 points, starting at 4-4 (no cap). Third game if necessary will be 15-point rally scoring with NO cap, starting 0-0. If a 1 game playoff is necessary, it will be one game to 15 starting at 0-0.

During Playoffs the losing team is required to officiate the following match. Tournament Director may allow a losing team to be released under certain circumstances.

Camp Area: Keep camp area clean and neat, do not spread out. If told by tournament officials to clean your area, please respect their directions.

In the age groups up to 14 and under, the Head or Assistant Coach must be the "up"-official. In all other age groups, coaches are to be court-side during their teams officiating duties. That means that there is an adult Head or Assistant Coach at either the ref stand, at the scorer's table or acting as line judge. Coaches who are not present or walk away during an officiating assignment will be penalized with a 5 points penalty PER SET in their next match.

In the age groups 15 and up, a coach needs to be in the R1, R2, or active scorer position.
